The President's Message

The new rules regarding the **charging of electric vehicles** were adopted by the Board at Tuesday's meeting and they'll become effective July 7, 2023. Thank you to everyone who sent in comments and suggestions. We reviewed them all and incorporated some. EVs are still a new technology and how we regulate them in our community is also new.

While we've tried to cover all the bigger issues, we couldn't possibly list every eventuality. They are rules of conduct for our neighborhood that depend on residents abiding by them in good faith. Ultimately the Board is the final arbiter of what is appropriate, what is a violation, etc. The Board can and probably will amend these Rules over time. Meanwhile, we think we've made a good start. Cathy Madden gets a big "thank you" for her assistance!

Electricity and water damage are two of our greatest expenses. If you're going to be away for more than a few days, you can save energy and avoid disaster by doing these three simple things before you walk out the door:

- 1) set the air conditioner to 85 degrees or "off",
- 2) flip the circuit breaker for your water heater to "off", and
- 3) shut off the water supply to your unit at the main valve (clockwise all the way = "off").

You may not know it, but your neighbors are watching out for you. We recently asked **Security to do a welfare check** by climbing in an unlocked window. Why? A package was left outside the door for over a week.

The car hadn't moved. Nobody answered the home phone, and we didn't have a cell phone number. We had no emergency contact



information. The key held at the Main Gate worked for the bottom lock, but the resident had also locked the dead bolt. Any of this sound familiar? The lesson is to give your nearest neighbor or Building Rep a simple 'heads-up' if you're going away, make sure Security has a key for ALL your locks, and update your emergency contact information. Please talk to your Building Rep about updating your 'green sheet'.

I've received several calls about a very dusty car with no license plate in the lot at the end of Building 11. The owner died and the title to the car could not be found. A new title has been applied for, but it will take some time. This is what happens when you don't keep your important papers where your family can find them.
